## FIELD NOTE DESCRIPTION 18.171 ACRES IN THE CHARLES WELCH SURVEY, ABSTRACT NUMBER 567 LIMESTONE COUNTY, TEXAS

BEING a 18.171 acre tract of land situated in the Charles Welch Survey, Abstract Number 567, Limestone County, Texas, (in conflict with the Archibald Powell League, Abstract Number 25, Limestone County, Texas, per Texas General Land Office), being all of that same called 17.6 acre tract described in instrument to BCP Land, LLC., recorded under Clerk's File Number 20192568 of the Real Property Records of Limestone County, Texas (R.P.R.L.C.T.), said 18.171 acre tract being more particularly described by metes and bounds as follows:

BEGINNING at a ½ inch iron rod found in the southeasterly margin of County Road 701 (C.R. 701), for a common corner of said 17.6 acre tract and those certain tracts shown to be owned by Leslie Schultz, per Limestone County Appraisal District (L.C.A.D.) ID Number 13304 (no deed record found), being the northerly corner of the herein described 18.171 acre tract;

THENCE South 32°04'52" East, 939.85 feet, with the common line between said 17.6 acre tract and said Schultz tracts, to a 3/8 inch iron rod found in the northwesterly line of that certain tract described in instrument to Kathryn M. Hunt, recorded in Volume 1345, Page 95, R.P.R.L.C.T., for the common southerly corner of said 17.6 acre tract and said Schultz tracts, being the easterly corner of the herein described 18.171 acre tract;

THENCE South 56°45'17" West, 838.87 feet, with the northwesterly line of said Hunt tract and that certain tract identified by L.C.A.D. ID Number 114462 (no owner information found), common to the southeasterly line of said 17.6 acre tract, to a ½ inch iron rod with cap found in the northeasterly margin of an existing dirt road, for the common southerly corner of said 17.6 acre tract and that certain called 23.1 acre tract described in instrument to Perry Allen Green and Paula Green, recorded in Volume 1202, Page 872, R.P.R.L.C.T., being the southerly corner of the herein described 18.171 acre tract;

THENCE North 31°40'02" West, with the common line between said 17.6 acre tract, the easterly margin of said dirt road, at a distance of 887.02 feet, pass a ½ inch iron rod found for reference, in all, a total distance of 955.56 feet, to a calculated point at the intersection of said existing dirt road, with the southwesterly margin of said C.R. 701, for the common westerly corner of said 17.6 acre tract and said Shultz tracts, being the westerly corner of the herein described 18.171 acre tract;

THENCE North 57°49'30" East, 831.80 feet, with the common line between said 17.6 acre tract and said Schultz tracts, with the approximate centerline of said C.R. 701, thence leaving said centerline, to the **POINT OF BEGINNING**.

CONTAINING a computed area of 18.171 acres of land within this Field Note Description.
