## FIELD NOTE DESCRIPTION 5.000 ACRES TRACT 6

## IN THE ANDREW BATEMAN SURVEY, ABSTRACT NUMBER 1 SAN AUGUSTINE COUNTY, TEXAS

BEING a 5.000 acre tract of land situated in the Andrew Bateman Survey, Abstract No. 1, San Augustine County, Texas, being a portion of a called 3,434.96 acre tract "Bateman Tract", as described in deed to Forestar (USA) Real Estate Group, Ltd., as recorded in Volume 94, Page 770, Official Public Records of San Augustine, Texas (O.P.R.S.A.C.T.), said 5.000 acre tract being more particularly described as follows:

COMMENCING at a  $\frac{1}{2}$  inch iron rod found w/cap in the easterly right-of-way line of Farm to Market Road 705 (100' R.O.W.), and being in the westerly line of a called 20.00 acre tract, as described in deed to Siert Martin Blok, III, recorded in Volume 90, Page 751 of said Office Public Records of San Augustine, Texas (O.P.R.S.A.C.T.), from which the northwest corner of said called 20.00 acre tract bears N03°26'44"E – 494.69', and from which a  $\frac{1}{2}$  inch iron rod found w/cap bears, N32°34'36"W – 3,864.92';

THENCE North 48°20'10"East a distance of 8,048.13', departing said easterly right-of-way line of Farm to Market Road 705 (100' R.O.W.), and severing said called 3,434.96 acre parent tract, to a ½ inch iron rod set w/cap "TPS 100834-00" for the southwesterly corner and **POINT OF BEGINNING** of the herein described tract, being in the centerline of a proposed 60' wide Utility and Access Easement, survey of even date;

THENCE North 30°32′12″W, departing said proposed 60′ wide Utility and Access Easement, at 30.0′, passing a ½ inch iron rod set w/cap "TPS 100834-00" for reference, a total distance of 536.64′ to a 4"x4" concrete monument found for the northwesterly corner of the herein described tract, being in the Sam Rayburn Reservoir line, called 1,937.00 acre tract, as described in deed to The United States of America, as recorded in Volume 127, Page 195, of the Deed Records of San Augustine County, Texas, (D.R.S.A.C.T.)

THENCE North 07°33'44"East a distance of 465.76', to a 4"x4" concrete monument found for corner;

THENCE North 89°05'59"East a distance of 69.96', to a ½ inch iron rod set w/cap "TPS 100834-00" for the northeasterly corner of the herein described tract;

THENCE South 29°03'32"East, departing said Sam Rayburn Reservoir, at 688.54', passing a ½ inch iron rod set w/cap "TPS 100834-00" for reference, a total distance of 718.54'to a ½ inch iron rod set w/cap "TPS 100834-00", in the centerline of said proposed 60' wide Utility and Access Easement, survey of even date, for the southeasterly corner of the herein described tract;

THENCE in a southwesterly direction with the centerline of said proposed 60' wide Utility and Access Easement, the following courses:

S47°23'53"W a distance of 144.62 to a point for corner; S41°50'06"W a distance of 108.01 to a point for corner; S13°47'06"W a distance of 122.07', to the POINT OF BEGINNING.

CONTAINING a computed area of 5.000 acres of land within this Field Note Description.

This Field Note Description was prepared from a survey performed on the ground on September 9, 2021 by Texas Professional Surveying, LLC., Registered Professional Land Surveyors and is referenced to Survey Drawing Project Number U27-62\_TRACT 6.
