THENCE South $41^{\circ} 57^{\prime} 13^{\prime \prime}$ West, 1035.88 feet, with the common line between said 127.395 acre tract and said 15.00 acre tract, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00" found in the northeasterly margin of U.S. Highway 287 (HWY 287, width varies), for the southerly corner of said 127.395 acre tract and the herein described 13.330 acre tract, from which a 2 inch iron pipe pipe found for the southwesterly corner of said 15.00 acre tract bears, North $41^{\circ} 57^{\prime} 13^{\prime \prime}$ East, 0.78 feet, and a concrete monument found for reference bears South $57^{\circ} 26^{\prime} 15^{\prime \prime}$ East, 216.41 feet;

THENCE with the northeasterly right-of-way of said HWY 287, the southwesterly line of said 127.395 acre tract, the following two (2) courses and distances:

1. North $57^{\circ} 26^{\prime} 15^{\prime \prime}$ West, 184.40 feet, to a concrete monument found for corner;
2. North $54^{\circ} 33^{\prime} 41^{\prime \prime}$ West, 312.69 feet, to a $1 / 2$ inch iron rod with cap stamped "TPS 100834-00' set for the westerly corner of the herein described 13.330 acre tract, from which a concrete monument found for reference bears, North $54^{\circ} 33^{\prime} 41$ " West, 2388.63 feet;

THENCE continuing over and across said 127.395 acre tract, with an existing fence, the following four (4) courses and distances:

1. North $49^{\circ} 13^{\prime} 47^{\prime \prime}$ East, 15.76 feet, to a gate post found for corner;
2. North $55^{\circ} 20^{\prime} 19^{\prime \prime}$ East, 793.37 feet, to a fence corner post found for corner;
3. North $20^{\circ} 47^{\prime} 28^{\prime \prime}$ East, 671.86 feet, to a gate post found for corner;
4. North $68^{\circ} 58^{\prime} 14^{\prime \prime}$ East, 29.12 feet, to the POINT OF BEGINNING and containing a computed area of 13.330 acres of land within this Field Note Description.
