BEING A 7.537 ACRE TRACT OF LAND SITUATED IN THE GEORGE SMITH SURVEY, ABSTRACT NO. 526, POLK COUNTY, TEXAS, THE REMAINING EASTERLY PORTION OF THAT 19.768 ACRE TRACT ONE DESCRIBED 22, 2019 FROM JOHIN DEED DATED AUGUST 22, 2019 FROM JOHN AUBREY AND DAVID BARICHELLO TO LEWIS SELF RECORDED IN VOLUME 2222, PAGE 174 OF THE OFFICIAL PUBLIC RECORDS OF POLK COUNTY, TEXAS, AND MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING AT A 4 INCH DIAMETER CONCRETE MONUMENT IN THE APPROXIMATE CENTER LINE OF COLITA LOOP FOR THE NORTHEASTERLY CORNER OF THE 19.768 ACRE PARENT TRACT, THE SOUTHEASTERLY CORNER OF THE ROBERT AND VIRGINIA AUBREY 3 ACRE TRACT (VOLUME 189, PAGE 415 POLK COUNTY DEED RECORDS), AND SOUTHWESTERLY CORNER OF A 0.142 ACRE TRACT TWO DESCRIBED IN SAID DEED TO LEWIS SELF:

THENCE WITH SELF'S EASTERLY LINE SOUTH 00° 10' 22" WEST 855.70 FEET TO A 1/2 INCH IRON ROD SET FOR THE UPPER EASTERLY CORNER OF A 6.751 ACRE TRACT SURVEYED THIS SAME DAY;

THENCE WITH THE EASTERLY LINES OF SAID 7.00 ACRE TRACT THE FOLLOWING 2 COURSES:

NORTH 65° 06' 32" WEST 448.17 FEET TO A 1/2 INCH IRON ROD SET FOR CORNER;

NORTH 20° 06' 05" WEST 476.00 FEET TO A POINT WITHIN COLITA LOOP (SET A 1/2 INCH IRON ROD 25.0 FEET SOUTHEASTERLY) IN THE NORTHERLY LINE OF THE 19.768 ACRE PARENT TRACT;

THENCE WITH AUBREY'S EASTERLY LINE NORTH 13° 52' 36" WEST 31.39 FEET TO A POINT FOR THE NORTHWESTERLY CORNER OF THE HEREIN DESCRIBED TRACT AND ITS 1.0669 ACRE PARENT (VOLUME 1765, PAGE 495 OFFICIAL PUBLIC RECORDS);

THENCE WITH THE NORTHERLY LINE OF SAID I.0669 ACRE PARENT TRACT NORTH 73° 18' 13' EAST 132.82 FEET TO A I-1/2 INCH IRON PIPE FOR CORNER;
